Dear Brothers and Sisters in Christ:

The Executive Board of CCCTO has scheduled a General Assembly meeting on December 3, 2023, from 11:00 AM to 12:00 PM, to elect the new pastor, elders, deacons and to obtain approval of the budget for 2024. During the meeting, the pastoral team will present the church vision. We will also hear from each ministry the 2023 summary and 2024 plans.

The Executive Board has approved all proposals that are being presented to you on this ballot. The Board of Trustees have also reviewed and approved the proposed 2024 budget. According to CCCTO's Constitution and Bylaws, the election of deacons and the approval of the proposed 2024 budget require a simple majority vote. The election of pastor and elders requires $\frac{3}{4}$ of the majority vote. 50% return ballots are needed to reach the quorum, so your participation, and voting are extremely important. Please allow sufficient lead time so your mail will arrive on or before December 2, 2023. You may also drop the ballot in the offering box at church when it's convenient, the deadline to collect the ballots is Dec. 2 at 5PM. For additional information, visit www.cccto.org/ga2023.
